BUSINESS MEETING:

Welcome and Introduction

WFC Board President, Maria Isley, called the business meeting to order at 6:16pm and welcomed 295 owners and guest attendees. Maria invited General Manager, Sarah Hannigan to the stage.

Sarah described the WFC ENDS Statement, the guiding path for our work and our business. Whole Foods Co-op is a thriving consumer-owned cooperative. Our Co-op is a steady and solid business that is held up by our staff, and is supported by our shoppers.

State of the Co-op Reports

Fiscal Year 2024 Annual Report

GM Sarah provided the state of the coop: fiscal year 2024 financials and progress toward the ENDS as articulated in the 2024 Annual Report. Highlights include \$22.6 million in sales; over half a million in discounts to Co-op owners and Co-op employees; and \$48,000 in net income (profit). 2024 was a strong and steady year.

The FY2024 Annual Report outlines our financials, but also our impact, which goes above and beyond just selling groceries. Different ways that WFC makes an impact in our community are:
